#### **Green Block Parties**

**The Maud Ave Block Party,** held on August 4<sup>th</sup> on the 1900 block of Maud Ave, hosted their annual party with the goal of creating a zero waste event.

Activities included a space for kids to make arts + crafts from recyclables, and a "sustainability trivia" booth where prizes included bamboo toothbrushes. Composting bins for all food scraps were placed along the street as well as recycling bins.



Ivy Tzur, a Ranch Triangle resident for 6 years, managed the planning for the block party. "This year we wanted to be more thoughtful about what we purchased for the block party, and how we managed our waste. Our front doors are within a few feet so

the block party planning team encouraged neighbors to use their home goods instead of disposables. For example, bringing out pitchers of beverages for the kids, instead of juice boxes or drink pouches. We also used a part of the budget for compostable plates, cups, and cutlery for anyone who didn't want to use their dishes, instead of purchasing any single use plastic. Signage was placed on the compost and recycling bins to ensure folks knew how to dispose of all things. Most importantly, we wanted everyone to walk away from this event having had a great time while also doing good for our community."

#### **Other Park News**

**Bissell Plaza, located at 1900 N. Bissell**, is a Chicago Department of Transportation (CDOT) public plaza. Local neighbors are developing a plan to rebuild Bissell Plaza to improve the public park space for to enhance its usability. Check with Alderman Michele Smith for details.

The Chicago Department of Transportation and their consultants have developed a plan for the **Dickens Greenway Project**. Earlier this year CDOT released the proposal to turn Dickens into a greenway, adding more greenery and a bike lane along Dickens. ## **Community Protests General Iron's Permit Extension**

Neighbors of Ranch Triangle and Lincoln Park recently held a protest march challenging the city's secret approval of a permit extension for General Iron until the end of 2022. The community questioned the legality of issuing the permit extension and called on the city to shut down General Iron until its operations are in compliance with city, state and federal environmental laws.

General Iron has been cited multiple times by the state for air, noise and water pollution. As a open-air, heavy metal crushing operation, General Iron daily releases particles of iron, lead, mercury zinc, cobalt, chromium into the air, onto the soil and into the Chicago River.

In the closing days of the previous administration, the city signed a contract extension with General Iron without notification to the community or to the 2<sup>nd</sup> Ward Alderman in whose ward General Iron is located.
